Enclosed is a county registration. The state bond form is located on the ODH website for any individual, partnership, firm, association or corporation. This application is to have his name placed on the register for those engaged in the installation of sewage disposal devices or equipment in 2025. A \$150.00 fee plus a **State bond and proof of 6 CEU's** must be submitted with the registration form. **Failure to obtain the current years CEU's will require a variance from our board at the cost of \$60.00.**

Call (937) 472-0087 for sewage inspections. The sewage permit number and name of home owner are the information needed in making an inspection request by telephone. Working hours are Monday thru Friday 8:00 to 4:00.

**As a reminder, please be aware of the following fees; sewage system re-inspection - \$60.00, permit extension fee - \$50.00, and sewage abandonment fee - \$40.00.**
